WE COMPLETED OUR 6TH CONTRACTUAL YEAR WITH THE CITY OF FLAGSTAFF AND COCONINO COUNTY IN 2024. WE WELCOMED 3,439 ANIMALS AND ADOPTED OUT 2,131 ANIMALS INTO NEW HOMES. WE ARE RUNNING A ROBUST FOSTER PROGRAM AND OVER 2,500 ANIMALS WERE CARED FOR THROUGHOUT THE COURSE OF THE YEAR BY 858 VOLUNTEER FAMILIES. OUR MEDICAL CLINIC PERFORMED 2,988 SPAY AND NEUTER SURGERIES. WE HAD 120 ACTIVE VOLUNTEERS WHO SERVED 5,800 HOURS AND WE HAD 747 PEOPLE ASSIST WITH OUR FOOD BANK RESOURCES TO FEED MORE THAN 6,00 DOGS AND CATS.
